## Registration steps

Below are the steps required to establish a New account on the FPRN:

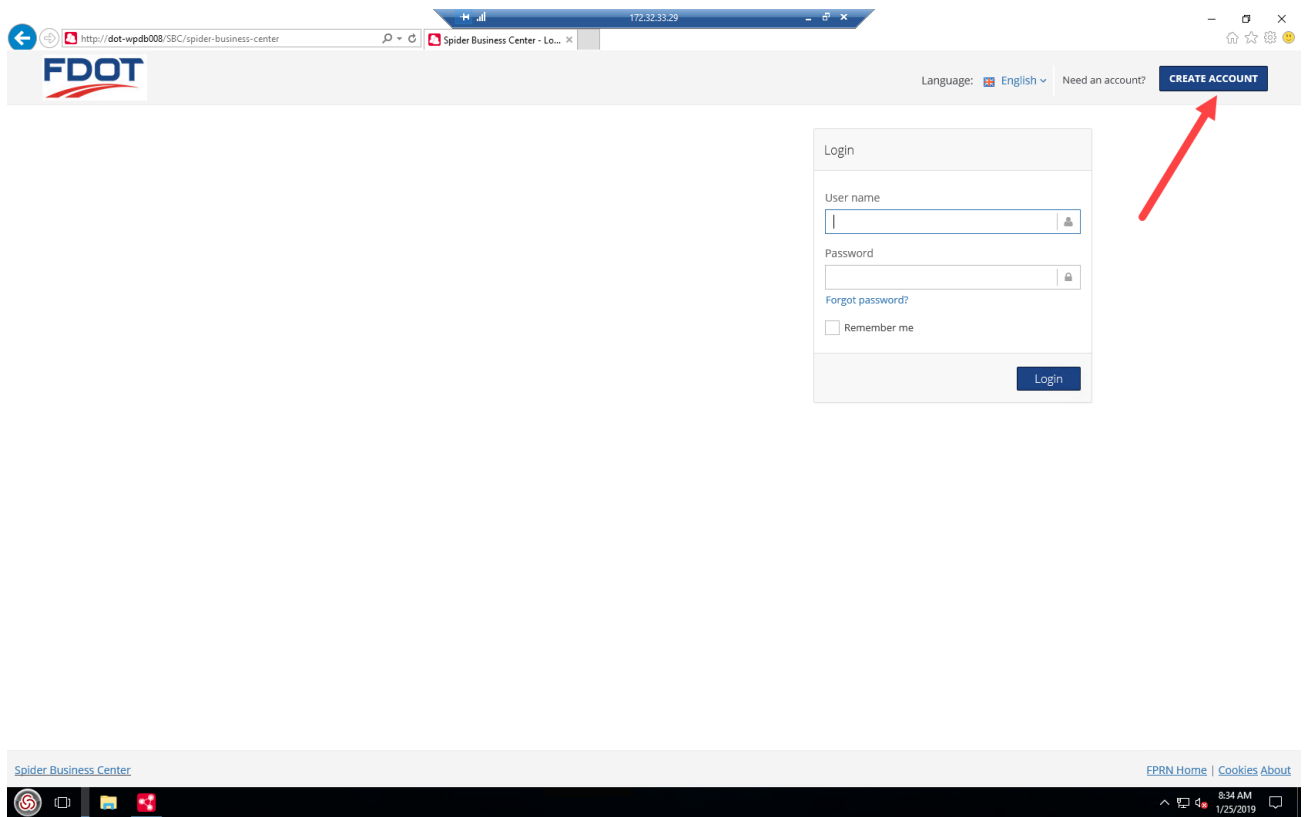
A new account **must** be created, however you can create the account with your existing User Name and Password to reduce configuration changes on your field equipment.

1. Please associate your user account to one of the following demographic groups:

(required during registration)

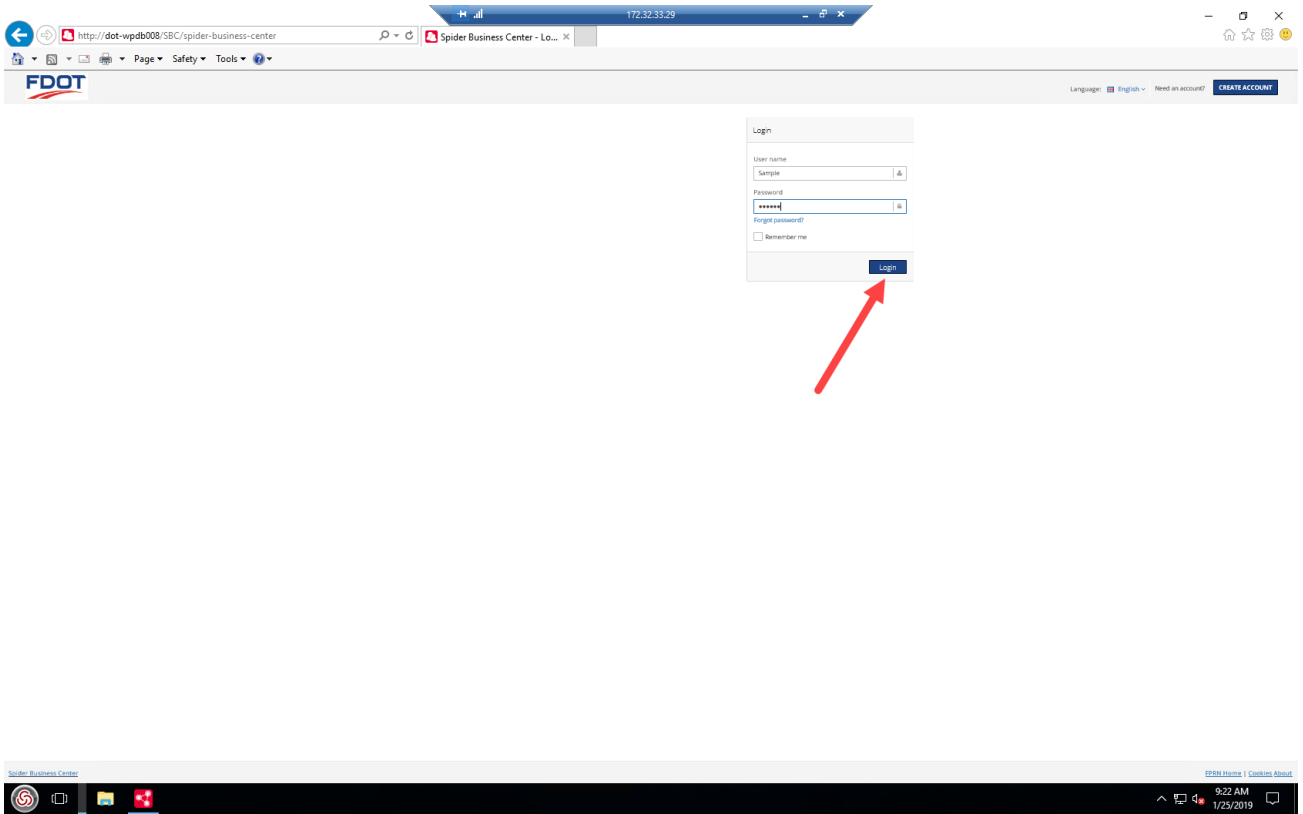

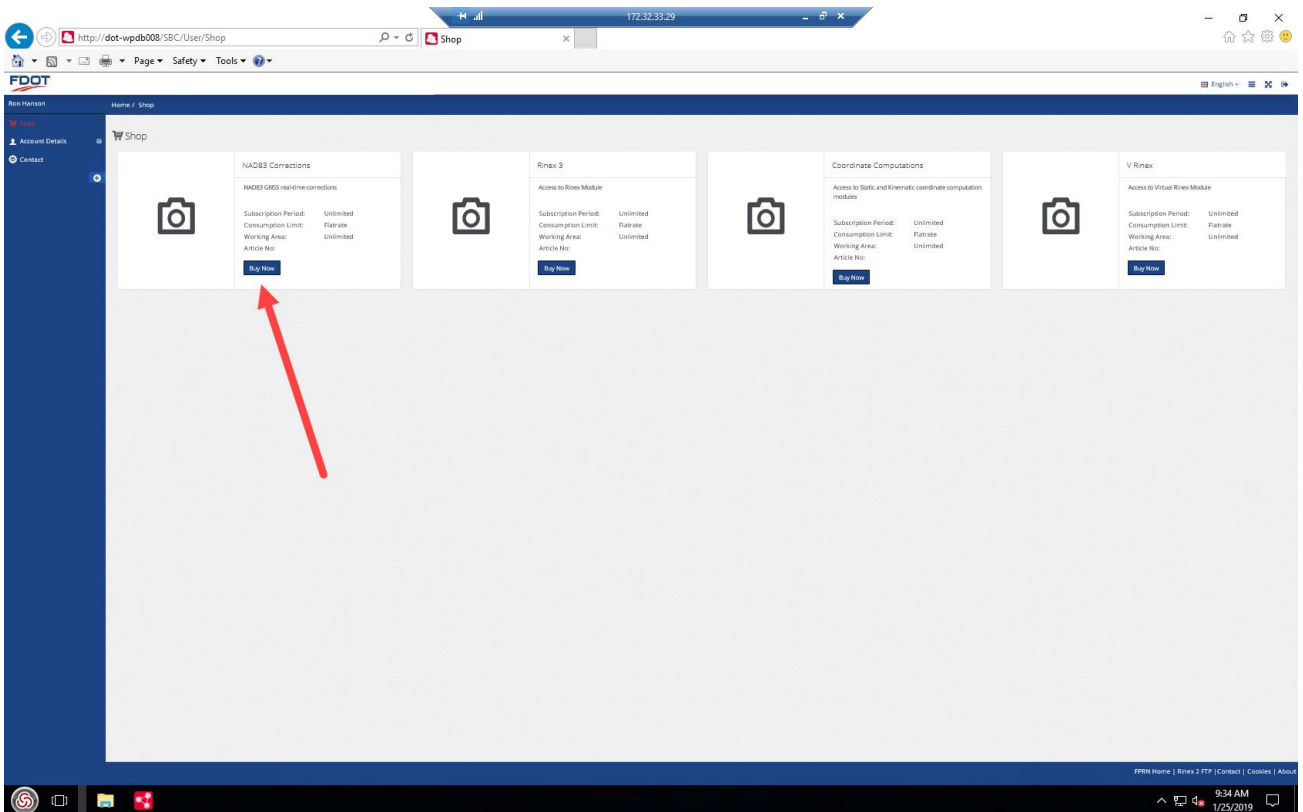
5. The system will send you an email at the address you entered in the registration form.

**You must click on the link in the email to verify and activate your account.**

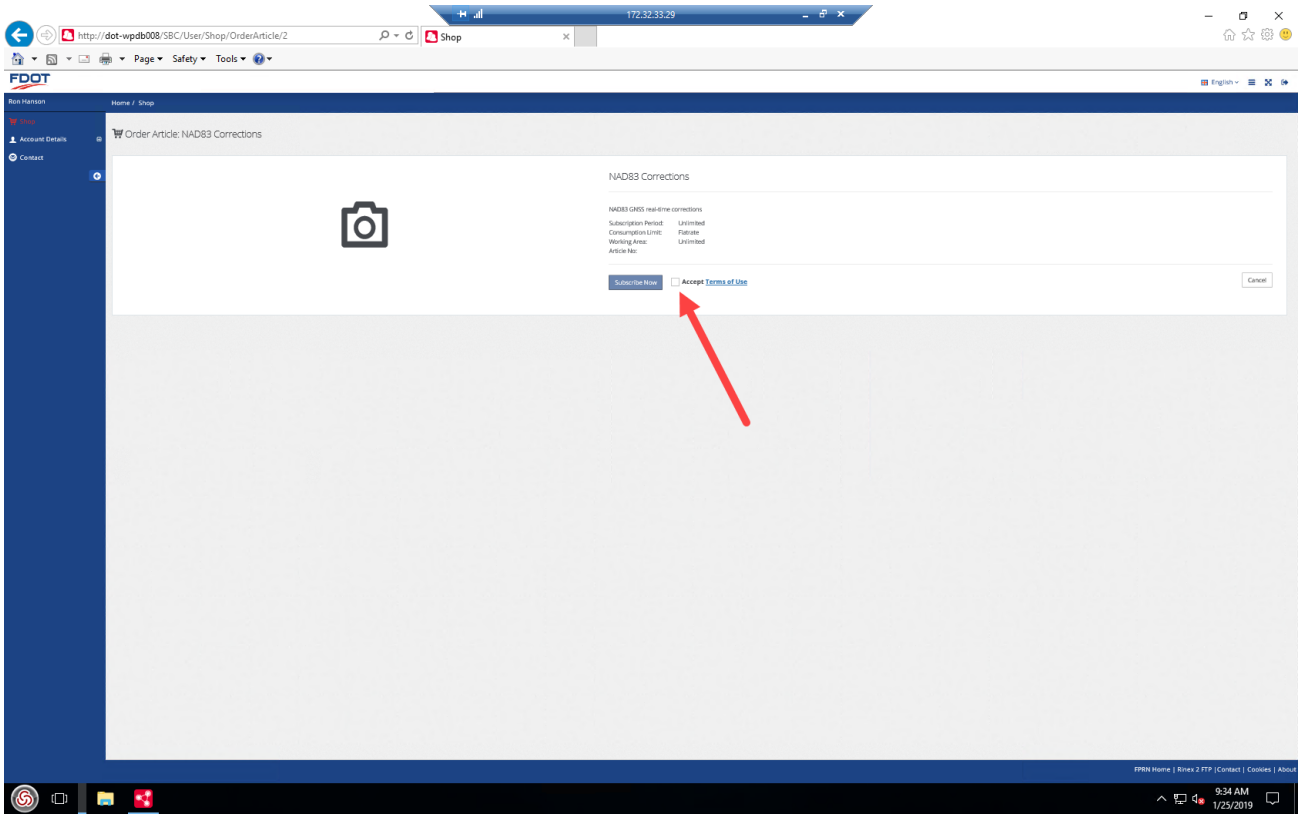
6. Log back into your account using your new User Name and Password



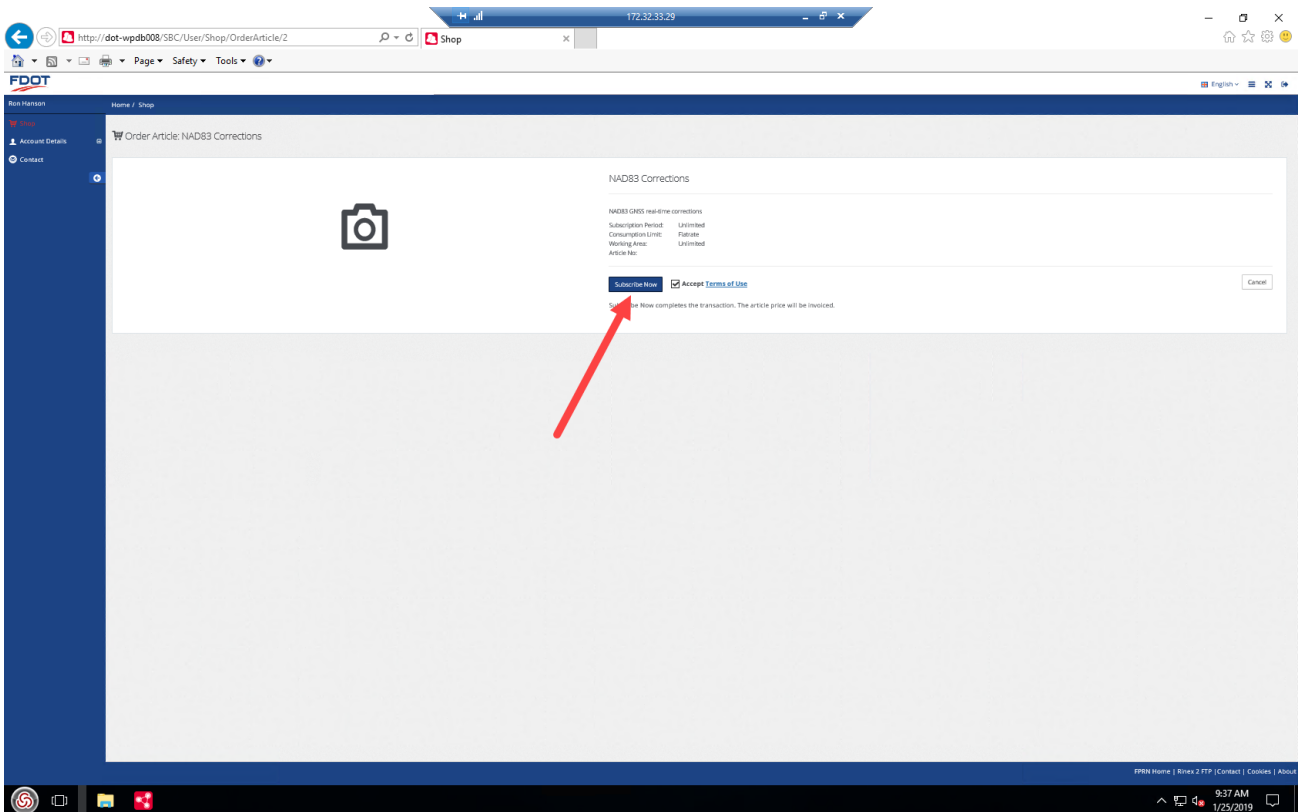
7. Go "Shopping" for the FPRN products you wish to use with your account.



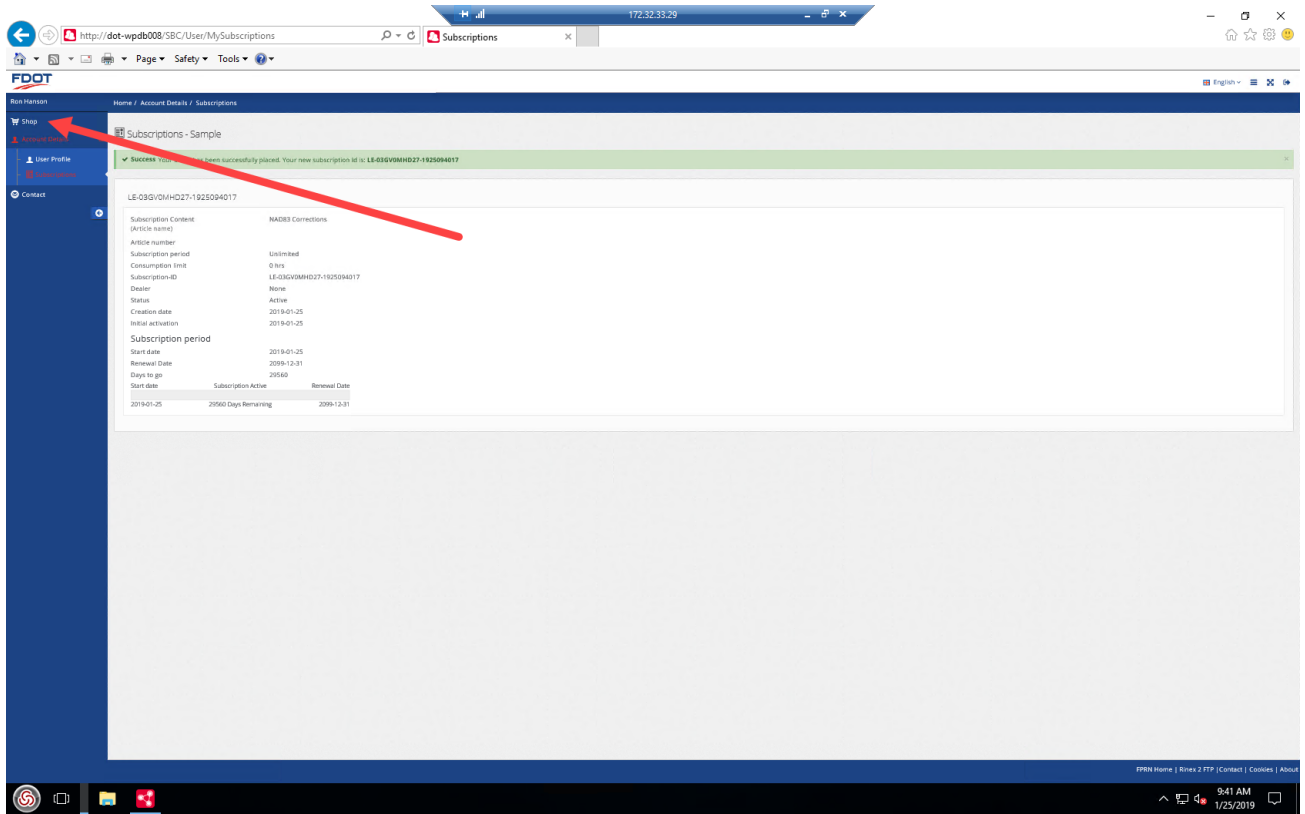
8. Accept the terms of use (You can view if you wish).



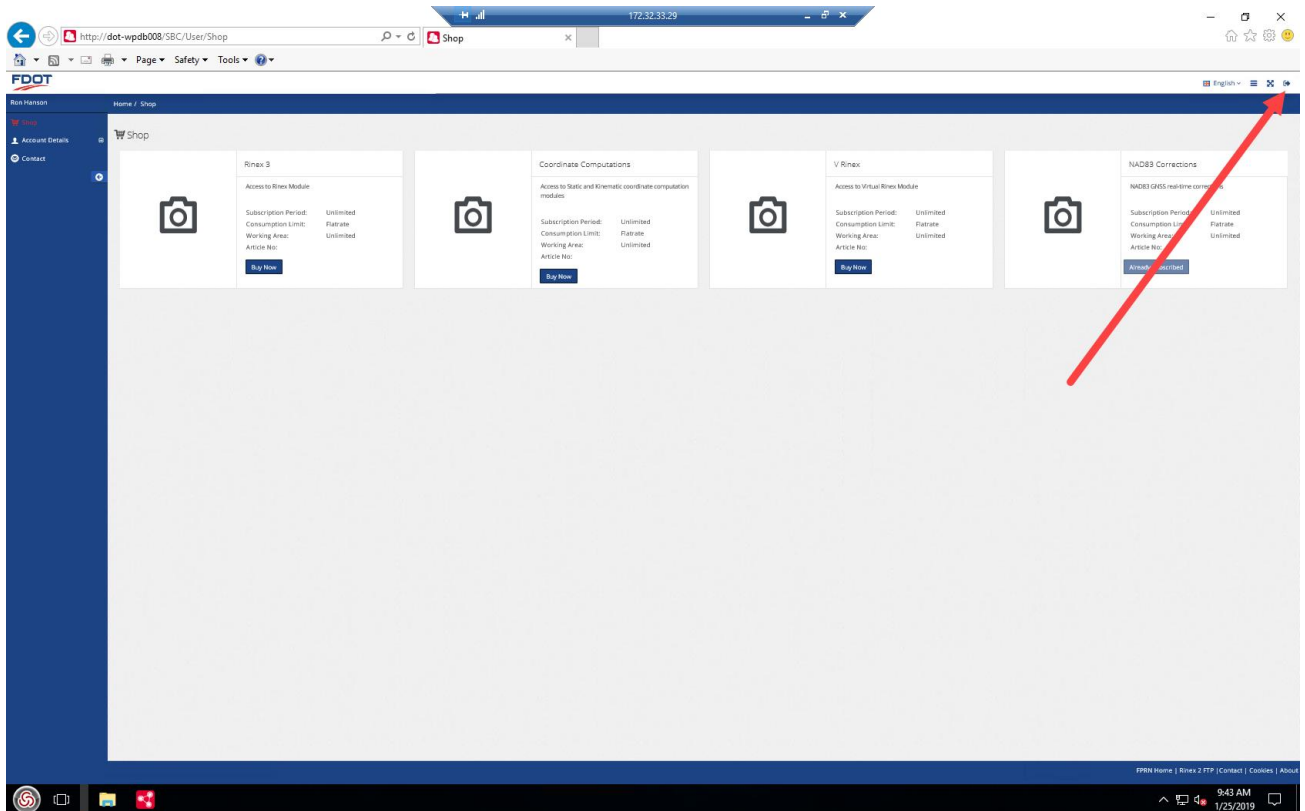
9. Click the Subscribe Now button to complete "Purchase".
